1. Implementation of Client Treatment Plans

- Responsible for implementing treatment plans provided by the BCBA® to address skills such as language and communication, social and play skills, adaptive functioning, etc.
- Use systematic methods and behavioural strategies to support clients in shaping their behaviour
- Teach and reinforce a variety of skills for children and youth in a 1:1 and/or small group setting
- Assist in conducting baseline measurements and other direct or indirect assessment measures as instructed by the Lead Therapist/BCaBA®/BCBA®
- Understands the functions of behaviour and responds appropriately and safely when situations arise
- Learn and apply the principles of Applied Behaviour Analysis (ABA)
- Adhere to all ABA training, procedures, and protocols
- Responsible for creating a positive, compassionate, and engaging environment for each client

2. Data Collection and Administration

- Responsible for tracking client progress through electronic data and graphing
- Responsible for completing incident reports as per company policies
- Prepares teaching materials and organises teaching environment
- Maintains workspace organisation and cleanliness
